No action will be taken on these items and no discussion will be had between the speakers(s) and members of the Board. The Board does retain the right to correct factual inaccuracies made by the speakers. If this item lasts longer than 30 minutes, then the balance of comments will continue as the last agenda item of the day.
- 3. Discuss and consider approval of regular meeting minutes for the July 15, 2025, regular meeting;
- 4. Discuss and consider action regarding District Treasurer's report, including:
 - a. Approval of monthly bills, invoices, and checks;
 - b. Approval of financial report.
- 5. Discuss and consider action on repaying Maintenance Tax and Revenue Anticipation Note No. 10822 between Real County Emergency Services District No. 1 and Government Capital Corporation assigned to Terry Lee Wilkinson;
- 6. Discuss and consider action on contract from Frio Canyon EMS;
- 7. Discuss and consider action on contract from Leakey Volunteer Fire Department;
- 8. Discuss and consider taking action regarding 2025-26 budget;
 - (a) Take a record vote to establish proposed tax rate;
 - (b) Taking record vote and scheduling public hearing;
 - (c) Authorizing expense and publication of "Notice of Public Hearing on Tax Increase" in the Newspaper; and
 - (d) Acknowledging and approving posting of "Notice About 2025 Tax Rates" and "Notice of Public Hearing on Tax Increase" to home page of District website.
- 9. Discuss the Real Central Appraisal District preliminary budget;
- 10. Discuss and consider scheduling budget meetings/workshops;
- 11. Discuss and consider District's next regular meeting day, time and place.
- 12. Adjournment.
