1. Call Meeting to Order.
2. Citizens' Comments. At this time, any person may speak to the Board if they have filled out a Participation Form. Comments will be limited to three (3) minutes per person. No action will be taken on these items and no discussion will be had between the speakers(s) and members of the Board. The Board does retain the right to correct factual inaccuracies made by the speakers. If this item lasts longer than 30 minutes, then the balance of comments will continue as the last agenda item of the day. Members of the public may address the Board, for a maximum three (3) minutes per person on items on the agenda. Members of the public will be allowed to speak on an agenda item after comments on the item are called for by the presiding officer, but before Board discussion and consideration of the item.
3. Discuss and consider approval of regular meeting minutes for the June 16, 2026, regular meeting.
4. Discuss and consider action regarding District Treasurer's report, including:
  - a. Approval of monthly bills, invoices, and checks; and
  - b. Approval of financial report;
  - c. Review and approval of quarterly investment report;
5. Discuss and consider approval of annual and quarterly reports and request from Frio Canyon EMS;
6. Discuss and consider approval of annual and quarterly reports and request from Leakey VFD;
7. Receive monthly updates from service providers: Frio Canyon EMS and Leakey VFD;
8. Discussion of the RCESD1 budget for fiscal year 2026-2027;
9. Discuss and consider service provider contract renewals and/or amendments.
10. Discuss and consider District's next regular meeting day, time, and place.
11. Adjournment.
