## **MEETING MINUTES**

## **REAL COUNTY ESD #1 for AUGUST 20, 2024**

1. *Meeting called to order* at 5:30 PM at 474 West Ranch Road 337, Leakey Texas 78873. Quorum was present with all Commissioner's present.

## 2. Citizen's Comments

Mr. Michael Learner spoke to the lack of a digital presence of the district online. Also, he spoke about the District's possible tax rate.

3. *Approval of Minutes* for June 18<sup>th</sup> and July 16<sup>th</sup> meetings. Agenda incorrectly had June 18<sup>th</sup> minutes needing approval instead of July 2<sup>nd</sup>. No action taken on June 18<sup>th</sup> minutes or July 2<sup>nd</sup> minutes.

- 6. **Adoption of the FY25 District Budget.** A proposed FY25 District budget was introduced. This budget is based on projected tax collection revenues submitted by the Real Central Appraisal District and the Real County Tax Assessor-Collector and at a rate of \$0.10 per \$100 of property valuation.

Discussion ensued regarding administrative, appraisal and loan repayment costs of operating the District and possible funding to Frio Canyon EMS and Leakey VFD.

Commissioner Adair motioned and Commissioner Gray seconded to approve the Proposed Budget. Motion carried 5-0

- a. Tax Rate Discussion was held and information shared regarding the critical staffing shortages affecting the Frio Canyon EMS and the Leakey Volunteer Fire Department and the effects of those shortages would have on service to the Community.

Commissioner Freeman motioned to adopt a rate of 10 cents/\$100 property valuation. Commissioner Adair seconded.
